Ms. Shamberg has over 30 years of experience in managing programs; working as a clinical therapist in pediatric school-based therapy, geriatric psych/physical disability rehab, nursing home, and homecare settings; and providing consulting services for elementary schools, educational institutions, businesses, community-service organizations, senior centers, and housing. She has degrees in both occupational therapy and special education with a specialization in assistive technology and environmental modifications. Ms. Shamberg is a Certified Brain Gym Consultant and Certified Irlen Scotopic Sensitivity Syndrome Screener/ Diagnostician. She has presented over 150 international training seminars on universal design, accessibility of the environment, and other topics related to independent living and authored numerous articles and textbook chapters on these topics.
